## For all firearms courses:

# 7. Disclosure

By signing, I understand, represent and agree that:

1. I am a citizen of the country(ies) listed above.

2. I represent and certify that I am legally entitled to firearms ownership and/or firearms possession and that I am free of any felony convictions within the United States of America.

3. My enclosed credentials meet the requirements outlined by American Academy of Protective Training (AAPT) and that at arrival at AAPT; I will positively identify myself as the same person certified in the application.

4. Range operations depend on careful control of deadly weapons by each student, and if any time during the course my cooperation is not deemed satisfactory to AAPT staff, my participation will be terminated.

5. I will abide by any and all safety procedures required by AAPT, and I agree upon my arrival, to complete, sign and understand a "Release and Indemnification Agreement" releasing AAPT from liability for any injury I may sustain or cause during my training.

6. I will be at least 18 years of age at the time of training or be accompanied by a parent or guardian.

7. My only purpose for seeking the training, which I have requested AAPT to provide me, is so that I may better be prepared to provide lawful service to my employer or in performing lawful acts for my own use.

8. I consent to having AAPT verify my identity and background as required under U.S. export controls, including the International Traffic in Arms Regulations (ITAR) and other applicable regulations.

9. Some AAPT courses are regulated for export by the United States government, including the U.S. Department of State, and that an export authorization may be required for the training of individuals who are NOT U.S. Citizens, U.S. legal permanent residents (green card holders) or political refugees in the United States. Information requested by AAPT regarding proof of citizenship is collected solely for purposes of compliance with U.S. export control laws and ITAR
